A MESSAGE FROM THE PRESIDENT

A little more than a year ago, Monroe County Community College celebrated its 50th anniversary. As we honored our storied history, we also began preparing for the college's next 50 years.

That preparation culminated in 2014-15 with the completion of numerous initiatives and projects to chart a course for the college's future direction. The goal is to constantly evolve with the times, adapt to changing needs and continue a record of excellence and service.



Last year, MCCC updated its mission and vision and completed two extensive college-wide planning

initiatives – a new strategic plan and the college's first-ever enrollment management plan. The latter was a result of the college's heavy focus on addressing decreasing enrollment following years of record growth. As part of these enrollment efforts, MCCC launched a new advertising campaign featuring successful alumni and a specific, short-term "triage" plan aimed at stabilizing enrollment as quickly as possible.

Also in 2014-15, the college finalized the integration of new general education requirements into all of its degree programs, approved a new model of governance, made several major campus repairs, and began working with Ameresco, a leading energy efficiency and renewable energy services provider, to significantly reduce the overall cost of installing a geothermal heating and cooling system throughout campus. This highly efficient geothermal system will provide major benefits such as a long life cycle, lower annual operating costs and improved comfort.

Despite an unsuccessful campaign last year for an additional tax levy for operations – the first attempt in 34 years – the college continued ongoing aggressive cost containment efforts while simultaneously working to meet current community needs and ready itself for the challenges that lie ahead.

I invite you to turn the page to find out more about many of MCCC's accomplishments in the past year, as well as how we are preparing for what the future holds for the college and the community.

Charting a Course for the Future

In 2014-15, Monroe County Community College completed numerous initiatives and projects to chart a course for the college's future direction and ready itself for future challenges. The goal is to constantly evolve with the times, adapt to changing needs and continue a record of excellence and service.

COLLEGE UPDATES MISSION AND VISION: ADOPTS NEW STRATEGIC PLAN

Throughout 2014-15, Monroe County Community College continued its comprehensive, campus-wide review of the college's mission and vision and development of a new strategic plan to lead it into the future. Teams consisting of a cross-section of individuals from all areas of campus reviewed each of the five existing strategic planning initiatives and recommended measurable objectives and associated tactics. The teams also noted the resources - personnel and economic required for implementing each tactic. After opportunities for input from all college employees, the Board of Trustees adopted the 2014-17 Strategic Plan and approved the college's new mission documents in April. Below are the updated mission and vision statements:

- ▶ Mission: MCCC enriches and transforms lives by providing opportunity and excellence in higher education.
- ▶ Vision: MCCC will be an innovative and progressive higher education institution and our community's first choice for quality post-secondary education.



A STRONG FOCUS ON STUDENT **RECRUITMENT, ENROLLMENT AND RETENTION**

After peaking at an all-time high in 2010, MCCC's enrollment has declined over the last five years. In response, the college is focusing heavily on evaluating the causes of decreasing enrollment and identifying appropriate interventions that support continued adherence to its mission. Efforts to evaluate and address declining enrollment are being addressed by the col lege's new Enrollment Management Plan that was developed last year and is now

being implemented. It focuses on student recruitment, retention and success. In addition, declining enrollment was addressed by the launch of the new "I Got MY Start at MCCC" marketing communications campaign and the development and implementation of a Fall 2015 Enrollment Triage Plan.

The new advertising campaign, which was developed by the Office of Marketing and Communications, was created mostly in-house and features numerous MCCC alumni now working in high-profile careers. It continues to run in cable, digital, print and outdoor mediums. The campaign has received very positive word-of-mouth feedback from employees and community members and generated thousands of social media hits.

The Fall 2015 Enrollment Triage Plan was launched in April to affect enrollment in the short term and included research and audience identification efforts, data capture of potential students at the point of inquiry for follow up, and a number of enrollment-driving campaigns to select audiences such as prospective, "returning" and current students. The various campaigns featured multiple direct mail postcards, emails and telephone calls.



Computer Literacy MCCC graduates are now required to regardless of their degree program.

Monroe County voters did not approve an additional property tax levy for MCCC in November 2014. It was the college's first request of an additional tax levy for operations in 34 years. Aggressive cost containment efforts have been underway at MCCC since 2008 to offset critical decreases to its funding streams. These efforts continue today due to basically flat state appropriations and property tax revenues following years of declines. The college is currently exploring another tax levy proposal in the future.



NEW GENERAL EDUCATION REQUIREMENTS FINALIZED

In 2014-15, MCCC finalized integrating new general education requirements into degree programs. General education unites students from diverse areas of study in the pursuit of knowledge that community college graduates should possess. At MCCC, general education courses are the foundation of each associate degree. The college now has six general education competencies that reflect its educational objectives: Natural Sciences.

Writing, Human Experience. Mathematics. and Social Systems. demonstrate competency in the six areas,

NEW COUNCIL MODEL OF SHARED GOVERNANCE APPROVED

After a three-year pilot, and with the support of all three councils - Administrator, Faculty and Support Staff and the president, the Council Model of Shared Governance became MCCC's permanent model of governance in 2015. The purpose of MCCC's Council Model is to organize internal constituent groups to promote open communication, deliberate college matters and convey recommendations to the college president.

A SUSTAINABLE, ENERGY-EFFICIENT **CAMPUS HVAC SYSTEM**

In the spring of last year, MCCC began working with Ameresco, one of the leading energy efficiency and renewable energy services providers, to significantly reduce the overall cost of installing a geothermal heating and cooling system throughout campus. The key benefits to the college of replacing its antiguated HVAC equipment with geothermal are the system's long life cycle, lower annual operating costs and improved comfort. Ameresco provides a simple solution to a big challenge facing facilities managers today: how to get the infrastructure upgrades needed at a time when budgets are too tight. Through

"Energy Savings Performance Contracting," the company leverages the cost savings from energyefficient equipment to provide capital to renew facilities and building systems.



REPAIRS COMPLETED ON CELLAR. LIFE SCIENCES BUILDING

- ▶ The Cellar Remediation Project was completed in fall 2014. The Cellar is a student gathering space in the Warrick Student Services/Administration Building that was damaged by frequent flooding. The project included removing existing floor finishes and trenching around the entire perimeter of the space, followed by the installation of new drainage tile and a sump pump. After the floor slab was repaired, a liquid vapor barrier was installed over the entire project area and new floor finishes were installed. Additionally, all the walls were painted and the soft furniture in the Cellar area was reupholstered.
- The Life Sciences Building Tuck-Pointing/Masonry Repair Project was also completed in fall 2014. New through-wall masonry flashing was installed along the entire north and south sides of the mechanical penthouse where it meets the second floor roof. This project included installing new brick, as needed, and cleaning and painting all exposed structural steel that was corroded where the new flashing was installed. Flashing was added to all masonry mechanical well walls, and they were painted.

Accessible and Flexible

Since its founding in 1964, MCCC has been here for people from all walks of life who are pursuing their dreams through higher education. The key is our ability to remain accessible and flexible to the needs of the individual student.

MCCC COURSES OFFERED AT **MONROE HIGH SCHOOL**

In September 2014, MCCC successfully launched a direct college program at Monroe High School that allows MHS students to take MCCC courses without ever leaving the high school. About

80 students were enrolled in four courses: Computer Science, English, Sociology and General Psychology.

MORE THAN 60 COLLEGES ON DISPLAY AT MCCC

In October 2014, the Monroe County Counselors and MCCC hosted College Night in the Welch Health Education Building. Admissions representatives from more than 60 colleges and universities were available to answer questions and provide information about their respective institutions. Grant, loan and scholarship professionals were also in attendance.

MCCC HOSTS CAREER AND **OPPORTUNITY EXPO**

Monroe County Community College hosted a Career and Opportunity Expo in March. The job fair was designed to bring together students, colleges, employers, veterans and community members. In addition to highlighting employment opportunities for the community, the expo specifically focused on available resources for our returning service members.

LIBRARY OFFERS REMOTE ACCESS **TO FULL E-BOOKS**

Last year, the MCCC Library's new SirsiDynix Enterprise software went live. The Library's Web presence now provides remote access to full-text electronic books through EBSCO.

A DAY TO RECOGNIZE STUDENT **VOLUNTEERISM AND SOCIAL RESPONSIBILITY**

In fall 2014, the MCCC Bookstore hosted National Student Day. This day was organized by the National Association of College Stores to recognize and encourage volunteerism and social responsibility among students. It was an opportunity for the Bookstore to give back while promoting a sense of community on campus.

NEW GLOBAL STUDIES DEGREE DESIGNATION ANNOUNCED

Dr. Joanna Sabo, professor of political science, last year led the development of a new degree enhancement now offered at MCCC called the Global Studies Degree Designation. Students in all majors can now earn this designation and have it added to their transcript if they take certain electives from an internationalized curriculum.


