Tips

- Each entry in the reference list should have a hanging indent (see p.37) and be double-spaced (see p.229).
- Include the digital object identifier DOI (see p.188) if one is available. It uniquely identifies many journal articles and other documents. If you provide a DOI, neither a URL, website name, nor retrieval date is needed as part of a reference (see p.191).
- If a database or document does not provide a DOI, you may use the Crossref Metadata Search at <u>http://search.crossref.org</u> to find one, if available.
- If a DOI is not available, include the URL for the home page of the database or website rather than the complete URL for the document (see p.191) but "add as much electronic retrieval information as needed for others to locate the sources you cited" (see p.187). Include a full URL if the source is difficult to find (p. 192) or if required by your instructor. Test any and all URL's to be sure the links work.
- Make certain your word processing software does not insert a hyphen into a long URL that spans many lines. Do not include a period after a web address or DOI (see p.192).
- Use a retrieval date if a DOI is not available and the content may be likely to change over time (see p.192).
- The name of the library database containing the article is usually not necessary (see p. 192). Include the library database name if required by your instructor.
- If there are no authors provided, begin the reference list entry with the title (see p. 184).
- Italicize only the volume number, not the issue number. Use of the issue number is required only if the page numbering starts over at page one in each issue (see p. 186).
- Precede the page numbers of a newspaper article only, but not journal articles, with "p." or "pp." (see p.200).
- The citation shortcuts provided by various databases are useful timesavers but should be checked carefully. Some common errors are over-capitalization in article titles, misuse of italics, and use of abbreviations instead of full names of months in dates.
- Does copy and paste from a database citation shortcut provide incorrect font styles, font sizes indents, or spacing in your *Word* document?
 - Try a different internet browser, such as Firefox instead of Microsoft Edge.
 - Try Word's *Paste Special* menu option and choose *Unformatted Text*. This will use the existing formatting of that section of your paper, but you will need to re-do italics, etc.
