MEMORANDUM OF AGREEMENT BETWEEN THE MONROE COUNTY COMMUNITY COLLEGE FACULTY ASSOCIATION, MCCCFA AND MONROE COUNTY COMMUNITY COLLEGE DISTRICT

The Monroe County Community College Faculty Association, MCCCFA and Monroe County Community College District ("District") hereby agree that the current 2019-2021 Master Agreement, which is set to expire on midnight August 22, 2021, shall be extended by one year and terminate August 22, 2022. The parties have agreed to the following items:

- 1. The 162-day academic calendar for 2021-2022 shall be observed (see attached).
- 2. For the 2021- 2022 academic year, faculty members on Steps 1-11 of the current salary schedule shall receive the next scheduled Step increase on the first payday of the 2021-2022 academic year.
- 3. All dates in the 2019-2021 Master Agreement shall be updated to reflect the appropriate new dates for the 2021-2022 academic year. Article XIII, Article XV and XVI (see attached)
- 4. All Insurance protection shall remain the same as detailed in 2019-2021 Master Agreement Article XV B., C.
- 5. All other 2019-2021 Master Agreement language remains the same.

LETTER OF UNDERSTANDING BETWEEN THE MONROE COUNTY COMMUNITY COLLEGE FACULTY ASSOCIATION, MEA-NEA AND MONROE COUNTY COMMUNITY COLLEGE DISTRICT

This Letter of Understanding (LOU) is entered into this _____ day of December 2020 by and between the Monroe County Community College Faculty Association, MEA-NEA ("MCCCFA") and Monroe County Community College District ("College"). In consideration of the mutual covenants hereinafter set forth, MCCCFA and the College hereby agree to enter into this Letter of Understanding regarding no tuition remission from the College for non-credit classes for Fall 2021 semester and Winter 2022 semester.

Article XV-Fringe Benefits, Section A 1. states "all faculty and their IRS dependents may be admitted to those Monroe County Community College courses for which they are eligible without payment of tuition and fees that pay for use of College-owned materials....." For Fall 2021 semester and Winter 2022 semester, both parties agree that the College will not pay for MCCCFA members and IRS dependents to participate in non-credit classes. Effective Spring/Summer 2022 semester, Article XV-Fringe Benefits, Section A 1. will be reinstated and will be in full force and effect.

The parties agree that this Agreement shall not be deemed a precedent or past practice for purposes of labor relations between the parties. The parties further agree that the resolutions reached in this Agreement are unique to the circumstances involved, and that they are in no way intended to be precedent setting with respect to future interpretations of the parties' collective bargaining agreement.
